WORK ENVIRONMENT

More than a century ago, Antonin Jaussen and Raphaël Savignac both Dominican priests of the École biblique de Jérusalem (now known as the École biblique et archéologique française de Jérusalem) traveled to Saudi Arabia with a scientific objective. During their journey, they discovered the sites of Hegra (Mada'in Saleh) and Dadan in the AlUla Oasis. Their surveys of the great Nabataean rock tombs, which are the region's hallmark, remain extraordinarily relevant, even though since then, numerous archaeological missions have been carried out in Arabia and in the oasis. In 2022, the 20th anniversary of archaeological collaboration between Saudi Arabia and France was celebrated. It was an opportunity to highlight the dynamic and strong French presence in Saudi Arabia, initiated by Professor Jean-Marie Dentzer and later followed by François Villeneuve.

In continuation of their work, an agreement was signed on February 21, 2024, between the University Paris 1 Panthéon-Sorbonne and the Royal Commission for AlUla for 5 years (2024-2029).

WORK ENVIRONMENT (continued)

Dedicated to the development of archaeology and preventive conservation in the Arabian Peninsula, and more broadly extending to the Arab-Muslim world, this programme focuses on two main topics: research and training. Six main themes structure the activities of the center and the collaboration between Saudi and French researchers, students, and academics, thereby ensuring a dynamic exchange of ideas and expertise:

- Environmental Heritage: Oasis Landscapes
- Conservation and Restoration in the Arabian Peninsula
- Archaeology 2030: Archaeology and New Technologies
- Arabian Peninsula: Cradle and melting pot of cultures and religions
- Arabian Peninsula:crossroads between the East, Africa and the Mediterranean
- Epistemology and Historiography of Archaeology and Conservation in the Eastern Regions.

PRESENTATION OF THE POSITION

The recruited post-doctoral researchers, starting on January 1, 2026, for a duration of two years, will contribute to the dynamic environment of the Jaussen & Savignac Archaeological Research Center by developing a research project within at least one of the six themes listed above. He or she will be expected to organize doctoral seminars and/or scientific events, and will be allocated a corresponding budget.

The postdoctoral researcher will carry out their work as part of one of the six research units associated with the Jaussen & Savignac Archaeological Research Center including UMR 8215 Trajectoires, UMR 8167 Orient et Méditerranée, EA 4100 HICSA within its welcome team Conservation Restauration des Biens Culturels, UMR 7041 ArScAn and UMR 8068 TEMPS, under the direction of a professor of Paris 1 Panthéon-Sorbonne University affiliated with ED 112 (Archaeology or Preventive Conservation).

CANDIDATE PROFIL

The selected post-doctoral researcher is required to have a PhD in Archaeology or Preventive Conservation. Two types of contracts may be offered, depending on the candidate's situation:

- In accordance with Decree No. 2021-1450 of November 4, 2021, relating to the public law post-doctoral contract provided for under Article L. 412-4 of the French Research Code, this type of contract must be awarded no later than three years after the candidate has obtained their doctoral degree.
- A project-based post-doctoral contract: Intended for candidates who completed their doctoral thesis more than three years before the start of the contract.

There are no age or nationality restrictions for applicants.

The file must contain the following documents in the order listed below:

- 1. Curriculum vitae Europass format of the applicant (maximum 2 pages),
- 2. A cover letter outlining the reasons for applying to the postdoctoral position, signed by the applicant
- 3. A research proposal of no more than 17,000 characters (including spaces, maximum 5 pages, in French or English; up to two illustrations may be included; the bibliography is counted within the limit); A doctoral seminar proposal (maximum 3 pages); a proposal for a scientific event (roundtable, symposium, etc.; maximum 3 pages).
- 4. A PhD thesis summary (maximum 4 pages),
- 5. A list of publications
- 6. A copy of the PhD diploma
- 7. The doctoral thesis defense report, translated either into French or English
- **8.** The commitment statement from the supervisor of the research project accredited by ED 112 (document available below).
- 9. The application form duly completed and signed by the applicant (document available below).
